

Happy Camper Contest Rules

1. No purchase necessary.
2. Must be 18 years of age or older to enter.
3. Contest is open to all residents of Alberta and Saskatchewan, Canada.
4. Contest commences on May 23, 2017 and concludes on August 26, 2017.
5. Contestants must find the CFCW Prize Patrol on location and fill out a Qualifier Entry form to enter.
6. Must be a CFCW Country Club Member to enter. You can become a member on-line at www.cfcw.com or with the Prize Patrol on-location
7. Each contestant can enter once per Prize Patrol location, per day. If the Prize Patrol is at more than one location in one day, contestants can enter once at each location in that day.
8. Starting June 19, 2017, and every weekday until August 25, 2017, we will draw two names from all of the entries at 8:40am. That person will have 8 minutes and 40 seconds to call us at 1-800-424-1344. If those people do not call within the allotted time of 8 minutes and 40 seconds, that person does not qualify and we will not draw another name.
